Interdistrict Agreements at Lassen View

Thank you for your interest in Lassen View! We pride ourselves in providing a great learning experience for students. Please be aware that our standards for behavior, work ethic, and dress code are high. Review this paperwork, our Board Policy and Administrative Regulations, and our Student Handbook before submitting your paperwork for approval to make sure Lassen View is the right fit for your family.

Lassen View does not deny students solely on the basis of an IEP. The school is limited in programs we provide on-site and current services may be impacted depending on the need of the student.

If accepted, the following stipulations apply for continued enrollment at Lassen View per AR 5117:

The conditions under which an existing interdistrict transfer permit may be revoked or rescinded:

- a. Attendance of student is less than 95% unless medical documentation provided excuses absences due to medical reasons. There should be less than 5 tardies during a school year.
- b. Poor grades- Student should have grades at a minimum of 2.0 with no D's or F's. If the number of missing assignments equals ten or more, the student's interdistrict agreement may be revoked. The district will schedule a meeting to discuss the student's grades and work ethic prior to revoking the agreement.
- c. Major behavior offense- A student's agreement may be revoked if involved in a suspension level offense including but not limited to fighting, bullying, possession or use of alcohol or drugs, possession of paraphernalia including a lighter, possession of a weapon, major defiance of a school staff member, vandalism, or inappropriate web site use.
- d. Continued minor level offenses- Lassen View uses a referral and ticket system for unwanted behavior. Referrals are used for lower level offenses and tickets are issued for higher level offenses. Three referrals will result in one ticket. If a student receives three or more tickets in a 6 month period, his/her interdistrict agreement may be revoked.
